## RULES AND REGULATIONS

- 1. The Hostels arc run under the general control of the Wardens where the prefects are chosen for every Block who will keep a general supervision in maintaining the discipline and cleanliness of the Hostels.
- The Inmates are given the provsion of both Veg & Non Veg. messes, which are run by the nominated secretaries on no loss, no profit basis.
- 3. The monthly bill shall be paid in full within ten days of the publication of the bill after which a fine of Re. 1-00 per day will be charged.
- 4. A deduction of Rs. 20/- per day is allowed on prior intimation and permission of the Warden.
- 5. The inmates shall not deal with the Hostel staff directly. However, they are free to give their opinions I suggestions to the Warden.
- 6. The Hostellers are not permitted to leave the hostel and go out without the prior approva!of the Warden.
- 7. The Hostellers must maintain absolute silence and engage themselves in studies in their respective rooms during the study hours.
- 8. No Hosteller shall enter or leave the hostel premises after 7-00 p.m.
- 9. Smoking and drinking liquor, playing cards and other unhealthy habits are strictly prohibited and considered indiscipline and punishable.
- 10. A Hosteller will be sent out of the Hostel for irregularity in studies, cutting classes, etc.

- 11. Hostellers are not allowed to accommodate or entertain any guests or friends to the Hostel.
- 12. RAGGING IN ANY FORM IS STRICTLY PROHIBITED.
- 13. MOBILE PHONES ARE STRICTLY PROHIBITED.
- 14. If the inmates are found using tape recorder with high volume, Immersion coil or any electrical appliance, the same may be seized by the authority.
- 15. A Hosteller will be summarily dismissed from the hostel without any enquiry if he is found guilty of misconduct.
- 16. Cases of illness should immediately be reported to the Warden who will make the necessary arrangements for the medical treatment.
- 17. Any Hosteller is found wasting water or electricity, will be penalized severely.
- 18. Mattresses are provided on rental basis for one year with return in good condition.
- 19. The caution deposit should be claimed within three years from the date of joining. Otherwise it will lapse on its own as it will be written off.
- 20. Admission to the hostel is on year to year basis and the students are required to apply for admission at the commencement of every academic year.
- 21. The Hostellers are strictly prohibited from associating themselves in any manner with any group which is not connected with the College.
- 22. Fees once paid will not be refunded on any ground.
- 23. The Hostel authorities reserve the right to add or amend any of these rules, frame such other appropriate rule from time to time.

## **DECLARATION BY THE APPLICANT**

- 1. I hereby declare that if I am admitted to the hostel I will abide by all the rules of discipline prevailing in the hostel and framed from time to time and I am fully aware that I am liable to disciplinary action which includes expulsion from the Hostel if I disobey the disciplinary rules.
- 2. I also declare that I will pay the fees and other dues to the Hostel in time.
